This letter that was later used as one of the plaintiffs' exhibits during the lawsuit contained information on how Brown & Williamson (a tobacco manufacturer) was working to stop the anti-smoking movement in Minnesota. I learned about how tobacco companies responded to adversity with marketing campaigns.

"Report on Visit to U.S.A. and Canada," by H. R. Bentley, D. G. I. Felton, and W. W. Reid (British American Tobacco Co. Ltd.). Trial Exhibit 2241 in State of Minnesota v. Phillip Morris, Inc.

This undated report, which later became a trial exhibit brought by the plaintiffs, was written by representatives of the British American Tobacco Co. It describes their visits to numerous medical experts throughout the United States and Canada. It states that, with one exception, all of the experts that they met with believed that smoking causes lung cancer. This report showed me how damaging the documents disclosed in the trial were to the manufacturers' case.
